

SUMMER SAFETY- DROWNING IS SILENT

As you enjoy your summer, please be mindful and vigilant about water safety for your children. Each summer, children tragically die from drowning. Drowning is the leading cause of death for toddlers 1-4 years old.

There are no warning or splashing sounds associated with a drowning accident. Signs of distress can include: head tilted back, hair over forehead, can't call for help, can't wave for help, body is vertical and "climbing ladder" motion. If you see any of these, please remove your child from the water immediately.

SILENT tips to keep your child safe:

S-SWIM SKILLS-Teach your children to swim at an early age, as backyard swimming pools account for over half of drowning deaths for children 0-5 years old each year.

I-Install Alarms-Install Alarms on house doors and around pool area.

L-Layers of Protection-Layers of protection include adult supervision, fences, gates, latches, safety pool covers, education, throwing aids and rescue techniques.

E-Eye-Adults should keep a constant eye on children in or near any water including bathtubs, buckets, toilets, ponds, spas and pools.

N-Never Leave a Child Alone-Never leave a child alone near water. Check the pool first if a child is missing.

T-Touch-Designate an adult to be close enough to reach out and touch the child.



San Joaquin County Expected to Get \$3.5 Million Grant Funding to Improve Oral Health Access and Services for Thousands of Low Income Children and Youth

Nearly 32,000 local children will receive oral health services including fluoride varnish, screening for cavities, referrals to dentists and other critical oral health services as part of a \$3.5 million grant awarded to the San Joaquin community by the Department of Health Care Services.

San Joaquin Treatment & Education for Everyone on Teeth & Health (SJ TEETH), a coalition of three dozen local health, education and nonprofit organizations, collaborated to develop the successful grant proposal to participate in the statewide Local Dental Pilot Program (LDPP) aimed at improving access to dental care for income-eligible children.

Tooth decay is among the most common chronic health conditions among young children, and poor oral health is one of the leading causes of school absence. For preschoolers, especially, untreated decay can make it difficult to play, speak, eat and learn.

In San Joaquin County, 28 percent of children ages 2-11 have never seen a dentist; this is the highest rate amongst the counties in the State.

Using grant funds, members of the SJ TEETH coalition will:

- Deliver preventative services, such as fluoride varnish, during visits to preschool classrooms and community sites.
- Screen children for cavities, or cavity risk.

- Refer families to dentists for continuing care.
- Promote the importance of oral health, including proper brushing and flossing techniques, healthy diet and regular checkups.
- Help coordinate oral health care for children.
- Facilitate collaboration among medical and dental providers.
- Introduce a Virtual Dental Home system to provide care to underserved children and youth.

New programs and services were implemented beginning June, 2017.

Family Resource Network is excited to be a member of the SJ TEETH coalition. FRN is working with families who have children with special needs within the project. If you need assistance finding a dentist in your area, and your child receives Medi-Cal services, is between the ages of 1-20, and you reside in San Joaquin County, FRN can assist you through this process. Please contact one of our Care Coordinators to participate in the SJ TEETH program at 209-472-3674.



First dental visits are mostly educational. The AAPD recommends that every child visit the dentist by the child's first birthday. The American Dental Association and the American Academy of Pediatrics recommend a child visit the dentist by age one as well. This "well baby check" for the teeth can establish a dental home and helps ensure that parents learn the tools they'll need to help their children remain cavity-free.

The Department of Developmental Services has announced that the application for federal funding, or Waiver, for the Self-Determination Program was approved by the Centers for Medicare and Medicaid Services (CMS). This news represents an essential step toward providing people who receive regional center services and their families an alternative way to coordinate their services, with more freedom and control over how the services are provided and the individuals who support them.

In October 2013, Governor Edmund G. Brown signed Senate Bill 468, authored by Senators Bill Emmerson and Jim Beall and co-authored by Assembly Members Holly Mitchell and Wesley Chesbro, into law. This law, championed by remarkable and determined self-advocates, family members and advocacy organizations, established a statewide Self-Determination Program that adheres to the following principles to ensure those who participate have:

- **Freedom** - to exercise the same rights as all citizens; to establish, with freely chosen supporters, family and friends, where they want to live, with whom they want to live, how their time will be occupied, and who supports them;
- **Authority** - to control a budget in order to purchase services and supports of their choosing;
- **Support** - including the ability to arrange resources and personnel, which will allow flexibility to live in the community of their choice;
- **Responsibility** - which includes the ability to take responsibility for making decisions in their own lives and accept a valued role in their community, and
- **Confirmation** - in making decisions in their own lives by designing and operating the system that they rely on.

While approval of the Waiver represents the key step towards implementation of the Self-Determination Program, the Department and the self-determination advisory workgroup must continue to focus on finalizing program components for implementation. Providing information and support, in particular training and orientation materials, needed to assist those who are selected and choose to participate is central to implementation and is in the final stages of completion. We remain committed to implementing this important program and look forward to the continued collaboration, not only with the Department's advisory workgroup, but also the local volunteer advisory committees and the Statewide Self-Determination Advisory Committee. The Department will publish a timeline with key dates for implementation by June 18, 2018.

Meet other siblings who share the same kinds of issues. There are games, crafts, discussion activities, food and lots of fun! There is no cost to attend.




Registration is required and must be submitted at least one week prior to event. Call 472-3674 or 800-847-3030 to request a registration packet.
